# Introduction

*Where Workers Work* features basic private sector employment totals (i.e., employment covered by the Illinois Unemployment Insurance Act) for six northeastern Illinois counties (Cook, Du Page, Kane Lake, Mc Henry, and Will), major communities in each of these counties, and zip codes within the City of Chicago. This is not the Chicago Metropolitan Division (MD). As of June 2003, the definition of the Chicago MD includes eight counties: Cook, De Kalb, Du Page, Grundy, Kane, Kendall, Lake, Mc Henry, and Will counties. Lake County is included in the Lake County-Kenosha County, IL-WI MD. Data for the other three Illinois counties (DeKalb, Kendall, and Grundy) that are included in the Chicago MD but not part of this report are available on the LMI Source Web site (<http://lmi.ides.state.il.us>), by selecting the Quarterly Census of Employment and Wages (ES-202) link, then Illinois At Work

*Where Workers Work* utilizes administrative data collected under the Illinois Unemployment Insurance Act. The Act requires employers to report employment and payroll information. This information becomes part of the Quarterly Census of Employment and Wages database (ES-202) on which *Where Workers Work* is based. The Act does not require employers to report their employment by individual work locations. However, since 1991, data in *Where Workers Work* do, wherever possible, reflect actual worksites of work locations as reported under the Business Establishment List (BEL) initiative discussed in the Special Comments section on page 4 of this report.

In addition to the BEL initiative, there have been a few other developments affecting *Where Workers Work*. Effective with the 1988-89 edition, **O'Hare International Airport** was reported as part of the City of Chicago rather than Northwest Suburban Cook; appropriate adjustments have been made so that the historical data shown in this edition also reflect that change. Effective with the 1972 edition, more than 20 **new suburban communities** were broken out from "miscellaneous" and "unclassified" groupings and are so noted. Effective with 2002 data, **another 19 breakouts** were added and are so noted. Finally, the zip code 60648 is no longer shown because the zip has been deleted by the US Postal Service.

The **industry breakouts** in these tables are identified by name and by NAICS (North American Industry Classification System) code.

# Highlights

The preliminary 2009 total for UI-covered employment in the metro area decreased to 3,236,557 - which is down 5.4% or 185,440 jobs.

Employment levels declined in Cook County and all of the 5 collar counties

The number of establishments increased overall for the Chicago Metro Area

The number of establishments doing business in the Chicago metro area increased 4,094 (+1.8%) from 2008 to 2009p (p=preliminary data) for a total of 234,281. Cook County had an increase of 2,904 (+2.1%), which included an increase of 1,827 (+2.9%) for the City of Chicago. Du Page County increased by 228 (+0.6%) establishments, Lake County by 188 (+0.9%), Mc Henry County by 84 (+1.0%), Will County by 559 (+4.2%), and Kane County by 131 (+1.0%).

# County Analysis

## Cook County

Cook County had a decrease in employment of 108,433 (-5.0%) from March, 2008 to March, 2009. The City of Chicago had a decrease in employment of 54,118 (-4.9%). Industry sectors with the biggest employment increases in the county during that time period were Health Care & Social Assistance (8,129; +2.7%), and Educational Services (5,354; +7.0%). Industries with significant employment losses were Administrative & Support, Waste Management & Remediation Services (-23,538; -13.1%), Manufacturing (-22,821; -9.9%), Construction (-12,732; -15.1%), Retail Trade (-12,423; -5.3%), Professional, Scientific & Technical Services (-10,029; -4.9%), Finance & Insurance (-8,781; -5.4%), Accommodations & Food Services (-7,815; -4.0%), Wholesale Trade (-7,508; -6.7%), and Transportation & Warehousing (-7,179; -6.3%).

## Du Page County

Du Page County had a decrease in employment of 35,903 (-6.7%) from March, 2008 to March, 2009. The biggest increases in industry employment occurred in Health Care & Social Assistance (1,650; +3.3%), and Educational Services (799; +6.6%). The industries with declines in employment included Administrative & Support, Waste Management & Remediation Services (-7,343; -14.1%), Manufacturing (-6,526; -10.9%), Retail Trade (-6,388; -9.4%), Construction (-3,861; -14.4%), Finance & Insurance (-3,091; -9.1%), Wholesale Trade (-2,685; -5.3%), Professional, Scientific & Technical Services (-2,294; -4.6%), and Transportation & Warehousing (-1,841; -7.6%).

## Kane County

Kane County had a decrease in employment of 13,014 (-7.4%) from March, 2008 to March, 2009. The industries having the biggest declines in employment were Administrative & Support, Waste Management & Remediation Services (-4,172; -20.6%), Manufacturing (-3,942; -11.7%), Construction (-2,550; -23.6%), Retail Trade (-938; -4.3%), and Wholesale Trade (-333; -3.0%).

## Lake County

Lake County had a decrease in employment of 15,967 (-5.6%) from March, 2008 to March, 2009. The biggest increases in industry employment occurred in Transportation & Warehousing (478; +11.7%) and Health Care & Social Assistance (337; +1.2%). The industries with declines in employment included Construction (-3,058; -20.0%), Manufacturing (-3,057; -5.9%), Retail Trade (-3,023; -6.8%), Administrative & Support, Waste Management & Remediation Services (-2,740; -13.1%), Professional, Scientific & Technical Services (-1,509; -7.7%), and Wholesale Trade (-1,121; -4.8%).

## Mc Henry County

Mc Henry County had a decrease in employment of 5,659 (-6.7%) from March, 2008 to March, 2009. Increases in industry employment occurred in Wholesale Trade (185; +3.5%), and Arts, Entertainment & Recreation (146; +12.0%). The industries having the biggest declines in employment were Manufacturing (-2,430; -12.8%), Construction (-1,290; -17.4%), and Administrative & Support, Waste Management & Remediation Services (-974; -16.0%).

## Will County

Will County had a decrease in employment of 6,464 (-4.0%) from March, 2008 to March, 2009. The biggest increases in industry employment occurred in Health Care & Social Assistance (570; +3.0%), and Accommodations & Food Services (524; +3.4%). The industries with declines in employment included Construction (-3,432; -24.3%), Retail Trade (-1,312; -4.8%), Manufacturing (-1,084; -5.3%), Administrative & Support, Waste Management & Remediation Services (-1,043; -12.0%), and Arts, Entertainment & Recreation (-495; -11.7%).

## technical notes

Data in *Where Workers Work* are: 1) preliminary for the most current year, 2) as of March for each year, 3) subject to revision in subsequent years, and 4) based on information collected under the Illinois Unemployment Insurance (UI) Act: The Illinois UI Act covers any employer of one or more workers in each of 20 or more calendar weeks or with a payroll of at least \$1,500 in any calendar quarter in the current or preceding calendar year. Data are for the private sector and exclude government workers.

## geographic definitions

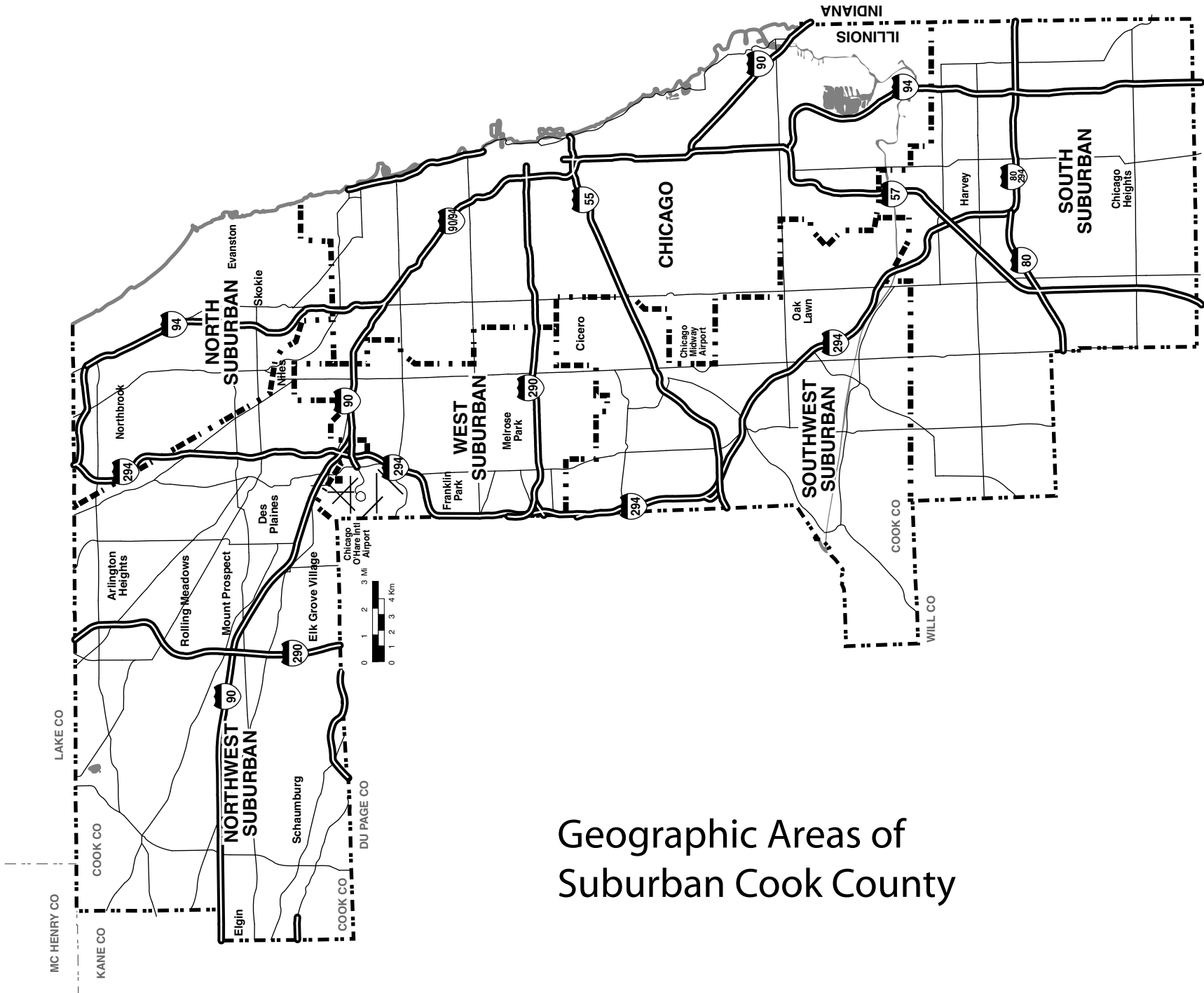
CHICAGO METRO AREA: Cook, Du Page, Kane, Lake, Mc Henry, and Will counties. This is not the Chicago Metropolitan Division (MD). As of June 2003, the definition of the Chicago MD includes eight counties: Cook, De Kalb, Du Page, Grundy, Kane, Kendall, Lake, Mc Henry, and Will counties. Lake County is included in the Lake County-Kenosha County, IL-WI MD. These two MDs combine with a third, Gary, IN MD, to form the Chicago-Naperville-Joliet, IL-IN-WI Metropolitan Statistical Area (MSA).

MISCELLANEOUS UNCLASSIFIED: A grouping of suburban communities or geographic areas that cannot be shown separately because none has been assigned a unique code. An explanation of Miscellaneous Suburban Areas is provided on pages 8-11 of this file.

## special comments

*Where Workers Work* utilizes administrative data collected under the Illinois Unemployment Insurance Act. The Act requires employers to report their employment, and this information becomes part of the Quarterly Census of Employment and Wages database (ES-202) on which *Where Workers Work* is based. The Act does not require employers to report their employment **by work location**. The US Bureau of Labor Statistics recently initiated a nationwide intensive effort to solicit employment information **by work location**, called the Business Establishment List (BEL). The first effects of BEL are reflected in 1991. Under BEL, employment for multiple work locations, that was traditionally reported wholly at a headquarters or central location, is now reported for each work location. This more accurately reflects the distribution of employment in Illinois, but caused an interruption in the data series as of 1991. We will continue to report data for years prior to 1991 as a courtesy (establishment tables appear again this year), but comparisons across time are discouraged.

**It should also be noted that specific community data may be impacted to a significant extent by employer reporting inconsistencies.**

# Where Workers Work Announces

The *Where Workers Work* publication features employment totals that are broken out by the North American Industry Classification System (NAICS) categories. NAICS provides industry categories which better reflect the United States and Illinois economies.

Industries are organized on the basis of their production activities (supply) alone, as opposed to the mixture of supply and demand characteristics used to classify industries under the SIC. NAICS also standardizes the classification system of the 3 partners in the North American Free Trade Agreement (NAFTA): the United States, Canada, and Mexico.
