IDES ICESA Gateway Acknowledgment 2

Process

Each submission to the IDES gateway will have an initial file transmission acknowledgment (ACK1) and a file acceptance acknowledgment (ACK2). Details for the transmission process and the ACK1 file format are available on the Illinois Department of Revenue website.

File Details

If the file is rejected, the response will only contain a copy of the "A" record and up to 5 error records describing the reject. If the file can be processed, each "A", "B", "E", "T", and "F" record will be included in the response along with an accepted or rejected status for that record and error details if available. Error code fields will be space filled if the row does not contain an error.

Wage report rejects will always have a reject status on both the "E" and "T" rows. The error message will appear with the record that caused the error. "S" records are not included in the response file and wage report level errors from "S" records will appear on the rejected "E" record.
